# Unit 15 / Hunting

(See Unit 15 Kenai map)

**Unit 15** consists of that portion of the Kenai Peninsula and adjacent islands draining into the Gulf of Alaska, Cook Inlet, and Turnagain Arm from Gore Point to the point where longitude line 150°00' W. crosses the coastline of Chickaloon Bay in Turnagain Arm, including that area lying west of longitude line 150°00' W. to the mouth of the Russian River; then southerly along the Chugach National Forest boundary to the upper end of Upper Russian Lake; and including the drainages into Upper Russian Lake west of the Chugach National Forest boundary.

**Unit 15A** consists of that portion of Unit 15 north of the north bank of the Kenai River and the north shore of Skilak Lake.

**Unit 15C** consists of the remainder of Unit 15.

**Unit 15B** consists of that portion of Unit 15 south of the north bank of the Kenai River and the north shore of Skilak Lake, and north of the north bank of the Kasilof River, the north shore of Tustumena Lake, Glacier Creek, and Tustumena Glacier.

## Special Provisions

- The **Skilak Loop Wildlife Management Area** is closed to subsistence taking of wildlife, except that grouse, ptarmigan, and hare may be taken only from Oct. 1–Mar. 1 by bow and arrow only. This area consists of that portion of Unit 15A bounded by a line beginning at the easternmost junction of the Sterling Highway and the Skilak Loop (milepost 76.3); then due south to the south bank of the Kenai River; then southerly along the south bank of the Kenai River to its confluence with Skilak Lake; then westerly along the north shore of Skilak Lake to Lower Skilak Lake Campground; then northerly along the Lower Skilak Lake Campground Road and the Skilak Loop Road to its westernmost junction with the Sterling Highway; and then easterly along the Sterling Highway to the point of beginning.
- Taking a red fox in Unit 15 by any means other than a steel trap or snare is prohibited.
- Bait may be used to hunt black bear between Apr. 15–June 15, subject to Kenai National Wildlife Refuge permit conditions.
- Use of aircraft, off-road vehicles, and firearms is subject to special Kenai National Wildlife Refuge regulations. Contact the Refuge at (907) 262-7021 for current regulations.
